







• Joint venture with ABILITY in VN

A joint venture with ABILITY established a subsidiary in Vietnam. The capital is NT\$150 million. AMPACS is expected to invest NT\$60 million to acquire 40% equity.

The investment of NT\$50 million in the first phase of the joint venture subsidiary has been completed.

The investment of NT\$20 million by AMPACS has been completed.
